# **Privacy Policy**

This Privacy Policy ("Policy") applies to www.kletzcontracting.com, and Kletz Contracting ("Company") and governs data collection and usage. # **Collection of your Personal Information**

The Company may collect anonymous demographic information, which is not unique to you, such as your:

-Age -Household income

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services.
