

Privacy Policy

This Privacy Policy ("Policy") applies to www.kletzcontracting.com, and Kletz Contracting ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include www.kletzcontracting.com. The Company's website is a Informational site. By using the Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

The Company may collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Household income

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. Sharing Information with Third Parties

Tracking User Behavior

Automatically Collected Information

The Company may automatically collect information about your computer hardware and software. Use of Cookies

The Company's website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server.
